CALL TO ORDER

Samuel Lawrence, Chair, called the meeting to order at 9:03 a.m. A quorum of seven (7) members was confirmed.

ADOPTION OF AGENDA

MOTION: Hunter Bohne moved, seconded by David Enigl, to adopt the agenda as published. Motion carried unanimously.

APPROVAL OF MINUTES

MOTION: Steven Howard moved, seconded by Irina Ragozin, to approve the minutes of August 2, 2016 as published. Motion carried unanimously.

MOTION: Hunter Bohne moved, seconded by Steven Klessig, not to adopt the 2015 IBC Chapter 17 during this code cycle and retain the current language proposed in SPS 362.1700 and to request DSPS staff schedule the Council to meet in early 2017 to discuss 2015 IBC Chapter 17 in full. Motion carried. Opposed: Bierce, Howard, Ragozin, Rinke

MOTION: David Enigl moved, seconded by Irina Ragozin, to request DSPS staff review 2015 IECC Chapter C408 and SPS 364.0313 for potential conflicts, redundancy and to verify the requirement for balancing, sequencing and operating narrative to present draft language at the next meeting. Motion carried unanimously.

MOTION: David Enigl moved, seconded by Corey Rockweiler, to adopt the DSPS recommended language to SPS 364.0701 with the modification of adding reference to Chapter 7 of the IMC and the Section 304 of the IFGC: Barometric dampers shall not be allowed for use with combustion air. Motion carried unanimously.

MOTION: David Enigl moved, seconded by Hunter Bohne, to postpone the discussion of SPS 361 until the next meeting, and to request that Stratford Homes to submit comments in writing. Motion carried unanimously.

MOTION: Brian Rinke moved, seconded by Irina Ragozin, to remove SPS 362.0910. Motion carried. Opposed: Klessig
